

Public Policy Updates and Action

The Fall elections are over, and we enter this quiet month of preparation for the new year. Action and education continue at all levels of the government and educational institutions. I encourage you to enjoy the season and be ready to join us for Advocacy Day on January 26, when the days will be lengthening again.

NATIONAL

The U.S. Department of Education was created by Congress to protect students' civil rights and ensure equal educational opportunity for all. After making deep staff cuts, the Department announced plans to move the day-to-day functions of key K-12 and higher education programs to other agencies.

AAUW is responding to the Administration's escalating effort to dismantle the Department — releasing statements from AAUW CEO Gloria L. Blackwell and joining letters to Congress in coalition to expand our impact. Now we need you to make your voice heard. **Let your congresspeople know through AAUW National two-minute activist or the link [Here](#).**

STATE

The State AAUW team continues to meet to monitor legislation and plan for the next legislative session. We are reviewing bills, and always looking for more eyes to review, so give me a call if you have an area of interest. There is an active AI workgroup talking about legislation on this front. Given the data that AI replicates and will augment current biases, such as misogyny and racism, it is important that there be government review and legislation around the algorithms and deployment in the educational realm, so this is truly important work.

January 25 is the AAUW Advocacy Day - The State team will be prioritizing bills over this month and working with other advocates to make our advocacy as efficient as possible. If you are interested or willing to set up appointments with legislators in your district, please contact Lisa Utter.

Also importantly, Washington Attorney General Nick Brown announced the creation of a Worker Rights Unit to lead the effort to uphold our worker protections and address wage theft. At the Federal level, there has been a dismantling of the UW Dept of Labor by defunding enforcement staff. More information on that [here](#). LOCAL

Snohomish County Elections were certified on November 25th.

The Charter Review Commission will start work in January, reviewing the document that governs our county. Following past practice there should be a robust round of meetings to get public input.

New school board members will be taking office soon. As we approach this next year with the Federal Education Department being restructured and perhaps eliminated, AAUW will want to monitor important Federal funding sources for schools such as:

- Title 1 for schools that serve high numbers of low-income students with programs of academic and non-academic support that improve students' academic growth
- (ESSA) Every Student Succeeds Act and (IDEA) Individuals with Disabilities Act funding that supports students in low-income areas and the Federal government's ongoing contribution to special education.
