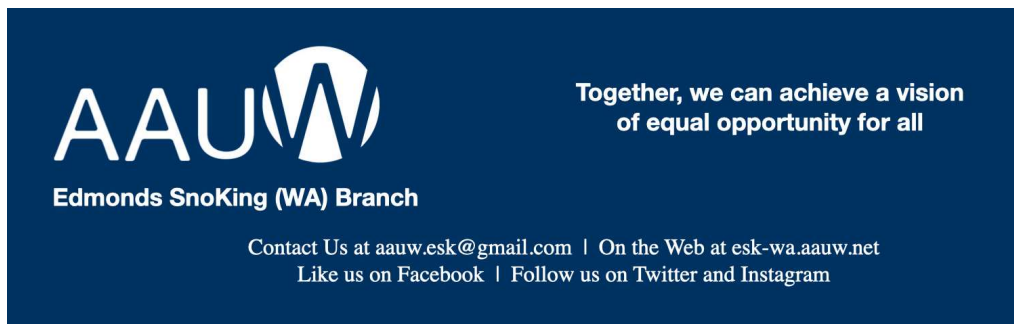

Public Policy Updates and Action

NATIONAL

Nationally, there are many issues on the burner from Education policy to voting rights. AAUW National has great tools to make your advocacy easier. You can sign up for Action Network emails [at Two Minute Activist](#). If the emails are too much you can just go to the main site and see the most recent Two Minute Activist actions with quick info to comment, call, or contact on an issue. But wait there is more, once you have signed up you can find basic information about your representatives from Congress all the way down to your city council - as well as contact information and all the social media feeds that they participate in. And you can log your relationships or interactions with these officials, which allows AAUW to keep track of where they stand on things AAUW has taken a stance on. Empower yourself, the organization, and advance our goals.

STATE

The 2026 Washington Legislature session starts on January 12th. It is a short session, scheduled to finish up 60 days later on March 12th. AAUW's virtual Advocacy Day is scheduled for Monday morning, January 26th.

I encourage everyone to use the [2026 Advocacy Day Check List](#) to get ready to meet with our legislators. We will schedule meetings with legislators for this area. Our legislative consultant, Nancy Sapiro, who provides a weekly update for AAUW, will provide an update online in the morning, and we'll arrange Zoom meetings with legislators later in the day. With a minimal investment of time, you can be up to date on our advocacy positions and prepared to talk to your legislator. If you

know your legislator, please consider arranging an appointment; the legislators really want to hear from their constituents.

AAUW's Advocacy focus this session will be AI but the legislature is also very focused on budget, and we'll want to monitor to ensure that programs that we support are not decimated by budget cuts.
